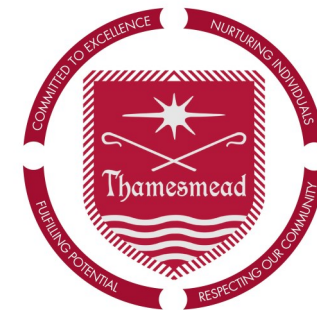

Dear Parent/Carer

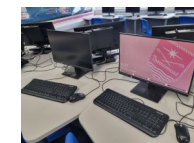
The aim of the **School Development Fund** is to raise money to support Thamesmead School's mission - that every student will realise their potential.
